
#### **MEETINGS**

#### **CO-OPERATIONS**

On the 6<sup>the</sup> of November 2015 the CSE signed a Memorandum of Understanding with HEPTech and EEN (Enterprise Europe Network) for the organisation of a yearly meeting under the name "European Cryogenics Days". The CSE is in close contact with the Cryogenics Society of America who published an article in *Cold Facts* about the establishment of the CSE - and with the British Cryogenic Cluster. Moreover, we successfully supported the "InK-2 -Introducing the new Kelvin" proposal led by prof. Graham Machin (National Physical Laboratory, UK), which has been approved and highly ranked. ## **EUROPEAN CRYOGENICS DAYS**

We are very happy to announce the organisation of the 2<sup>nd</sup> European Cryogenics Days "Cryogenics@CERN" hosted by CERN on the 9th and 10th of June 2016. Johan Bremer will chair the event and the preparations are in progress. The idea is to organize the meeting much along the lines of the Grenoble meeting.

On Thursday June 9<sup>th</sup> we will have the second CSE General Meeting followed by three plenary oral sessions. On Friday we have two plenary oral sessions followed by visits to CERN labs in the afternoon. The oral sessions will all be centred around a single topic. Each oral session starts with a 30 min presentation by one of the CERN representatives and will then be followed by three short talks, each of

20 min, related to the same topic and presented either by CERN or non-CERN staff. There are already quite some suggestions on topics as well as on speakers, so please block your agenda for these dates!
